Visa to travel to Vietnam

Some nationalities need a visa in-advance for all visits, some don't. The standard length of stay for tourist visas is 30 days; for visa-exempt nationalities it is 15 days. The online Evisa is an Electronic authorization that permits citizens of eligible countries to travel to Vietnam. It is an electronic visa that permits its holder to visit Vietnam for touristic, business or medical purposes for up to 60 consecutive days.

Before applying, make sure your nationality is one of those approved for Vietnam's e-Visa: Andorra, Argentina, Armenia, Australia, Austria, Azerbaijan, Belarus, Belgium, Bosnia and Herzegovina, Brazil, Brunei, Bulgaria, Canada, Colombia, Croatia, Cuba, Cyprus, Czech Republic, Chile, China (including Hong Kong and Macau passports), Denmark, Estonia, Fiji, Finland, France, Georgia, Germany, Greece, Hungary, Iceland, India, Ireland, Italy, Japan, Kazakhstan, Latvia, Liechtenstein, Lithuania, Luxembourg, Macedonia, Malta, Marshall Islands, Mexico, Micronesia, Moldova, Monaco, Montenegro, Mongolia, Myanmar, Nauru, Netherlands, New Zealand, Norway, Palau, Panama, Papua New Guinea, Peru, Poland, Portugal, Philippines, Qatar, Romania, Russia, Salomon Islands, San Marino, Serbia, Slovakia, Slovenia, South Korea, Spain, Sweden, Switzerland, Timor Leste, United Arab Emirates, United Kingdom, United States of America, Uruguay, Vanuatu, Venezuela, and Western Samoa.

To request a <u>Vietnam visa on arrival</u> first visit this page, which has all the basics. The whole process took maybe 10 minutes, and within two days my e-visa was approved. I was told that it typically takes about three days to have your visa approved. My expectation was that I'd receive an email confirming my visa application and the registration code. However, I never received that, and also never received an email confirming that my visa was approved.

If you are planning a multiple-entry visit or a stay of more than 30 days, you will want to apply for a visa on arrival. To do this you'll need:

- 1. A 4x6 passport photo with a white background and no glasses
- 2. A filled-out visa application form
- 3. A passport or substitute ID valid for six months from the date you plan to enter Vietnam
- 4. Payment (25 USD to 50 USD) for visa fees, and
- 5. A Letter of Approval from a Vietnamese embassy or consulate (if you are picking up your visa at the airport)

If you are near a Vietnamese embassy or consulate, you can submit your photo, application form, passport, and visa fee in person. This website will guide you through the process.

If you are unable to reach a Vietnamese embassy, or are short on time, there are trusted services online who can provide you a valid Letter of Approval for a fee. Bring this letter and together with a visa application form and your other documents to the Visa on Arrival counter at the airport when you land.

The process of applying for a Vietnamese visa was super easy. It took about 10 minutes, cost \$25, and was approved within a couple of days, so that's a great improvement over the old system. There are a few things to be aware of during the process, but otherwise this is a really user-friendly system they have, in my opinion.

Your passport must have validity for a minimum of 30 days beyond the visa expiry date. For example, in case you enter Vietnam today and your visa expires in 30 days, then your passport must be valid for at least 60 days. Ports of entry that permit the use of <u>Vietnam Evisa</u>:
